VERIFY CERTIFICATION—A REMINDER!

Attainment of American Board of Health Physics (ABHP) Certification is increasingly viewed as a required or desired credential for the assignment of some radiation-protection responsibilities. As the value of certification increases, so too does the potential of fraudulent claims of CHP status. The American Academy of Health Physics (AAHP) and ABHP encourage licensing/regulatory agencies, employers, and contract officers to verify the certification status of potential or current employees or contractors. In addition, the AAHP and ABHP encourage anyone contemplating securing the services of a health physicist who claims to be certified by the ABHP to verify the certification status of the applicant. Verification can be performed by consulting the list of Active Certified Health Physicists in the Radiation Safety Professional's Membership Handbook and Directory (the HPS membership handbook) or on the AAHP Web site at:
