### AAHP Appeals Committee

The American Academy of Health Physics (AAHP) Appeals Committee evaluates appeals regarding American Board of Health Physics (ABHP or Board) decisions on candidate applications, examinations, certifications, and/or certification renewals. Appeals may be filed with the Executive Secretary by any individual who is denied:

- Eligibility for any part of the examination,
- Part I or Part II passing,
- Certification for any reason, or
- Renewal of certification.

The Appeals Committee determines whether or not the policies and procedures of the Board were properly followed. The committee reports its findings to the appellant, the ABHP chair, the AAHP president, and the AAHP program director. Current members of the committee are Jason Marsden and Duncan White.

### American Board of Health Physics

The American Board of Health Physics (ABHP) held its fall meeting in McLean, Virginia, 16–17 November 2012. Based on the exam results ([see the January 2013 “CHP Corner”](#)), the ABHP granted 15 new certifications in 2012.

The Board applauded panel members for the time and effort they contributed to the preparation and grading of the examinations. Special thanks were given to Jay Tarzia and Glenn Sturchio for chairing the Part I and Part II Exam Panels, respectively. Preparing the exams is a significant effort and

we all must not lose sight of the fact that the extensive time that the chairs spend is on a volunteer basis. Their hard work is sincerely appreciated.

This year the Board recognized the passing of a current member, Rob Forrest. Past Board member Nora Nicholson was nominated to the AAHP for completion of Rob's term, and the nomination was accepted. We thank Nora for doing this in addition to her representation of the ABHP to the Council of Engineering and Scientific Specialty Boards, the ABHP's accreditation body.

Those who have served on the Part II panel are familiar with the exam-development process, which has included development of questions followed by balloting of those questions for inclusion on the exam. The Board has now separated the processes of question development and exam preparation so that the Part II vice chair leads the process to develop questions for the Exam Bank and the Part II chair focuses on preparing the exam completely from the Exam Bank. For those outside of the panel interested in developing questions for the exam, receiving recertification points will now require their question to be entered into the bank, as opposed to actually being a part of the exam as was required previously.

The term expired for one member of the ABHP, Jack Higgenbotham; Andy Karam joins the Board as a new member (effective 1 January 2013). The 2013 Board is comprised of Chair Govind Rao, Vice Chair Patrick LaFrate, Secretary George MacDurmon, Parliamentarian Sharon Dossett, and members Nora Nicholson, Andy Karam, Mark Miller, and Gus Potter.

On a personal note, I'd like to add to the annual tradition of offering my thanks to Nancy Johnson for all of the work she does. She truly makes the certification process run. I'd also like to thank Kent Lambert for all of the advice and help he's given me this year.
