Important Notice for Medical Users

NRC has proposed amending its regulations to require licensees who use radioactive materials for medical purposes to establish and implement a quality-assurance program, with the objective of preventing errors in administration of the materials to patients. The Commission is also considering changes to its reporting and recordkeeping requirements related to medical uses of radioactive materials. The proposed amendments are intended to enhance patient safety, while allowing the flexibility necessary for proper medical care.

In an earlier proposed rule issued on October 2, 1989, the Commission proposed to require medical use licensees to implement a quality-assurance program consisting of specific quality-assurance procedures to prevent errors. However,
