Zach has been busy lately as the program committee task force chair for the HPS' virtual workshop. If you are reading this and are happy to have earned some continuing education credits from this year's virtual workshop, much of the scheduling, organizing, and general herding of cats rested on the shoulders of Zach and his amazing team of volunteer professionals. His wife likes to remind him that perhaps he studied too much when preparing for the exam: January to July an hour per weekday and another 6 or so on Saturday and Sunday. Although he sat for the exam on his birthday and was exhausted at his party afterwards, he had a real good feeling he

passed. The hard work and support from his wife paid off!

Pass his advice on to those you mentor: "For younger HPs, or students about to become HPs: get involved! Join committees and sections and local chapters. Even if you feel intimidated, they will be a huge benefit to you. The networking alone is worth it. Getting involved in these things is one of the best choices I've made in my career."

NOTE FOR RECERTIFICATION AND DEFERRED APPLICANTS

There has been some confusion about the recertification process since the point accumulation has become computer based. To recertify the individual needs to complete Appendix Q, "APPLICATION FOR RENEWAL OF CERTIFICATION OR FOR EMERITUS STATUS" of the ABHP Procedures Manual. The credit accumulation area that is currently in the procedure is electronic and available to the ABHP, but the forms in the procedure shall be filled out and sent to the Secretariat with the references.

To the 87 Part I and 68 Part II applicants who deferred their 2020 examinations (including the 15 applicants taking both examinations): **please register again to take the examination(s) in 2021**. This is done through the Prolydian system you used with your original application. Log in to Prolydian and resubmit the application. This will get you into the testing system. The application portal will be open until January 15, 2021. No fees are due to the Board for your application or for taking the examination(s) if you paid them last year. If you did not pay your fees make sure you do so by January 15, 2021.

In these uncertain times a vaccine cannot come soon enough. The Board will maintain vigilance on the potential impacts on the 2021 examination. The Part II examination will be given July 26, 2021. The Part I is not scheduled yet but will most likely be within 2 weeks of the Part II examination.

Great strides were made last year with getting the grades out in August versus the typical November. Even though the results are available immediately as you would expect there is a process the Part I panel is required to move through to certify the results are fair and accurate. Remember all of the Panel (I and II) and Board members are volunteers, most are working full time jobs. I want to thank them for their dedication and hard work! They have done an outstanding job to maintain the professional standards of the Certification process.
