#### PRESIDENT'S LETTER

I would like to start off the New Year with thanks! Thanks especially go to all of you who have volunteered, some of whom worked tirelessly in your "spare" time this past year on committees and other activities within the Academy. At the end of this letter, I will call out those volunteers who are rolling off of service for a well-deserved rest... or in some cases, even more service! Please take time to offer them your personal thanks as well.

There have been several enormous changes in 2020 that have affected our members/future members:

- On January 1, 2021, we transitioned our Secretariat from Burk and Associates (BAI) to Creative Marketing Alliance (CMA), located in Princeton Junction, NJ. After many decades of a relationship with BAI, you might imagine that the transition was quite a bit of work. The transition Task Force was headed by Wayne Gaul who was assisted by Pat LaFrate, Andy Miller, Gus Potter, and Wei-Hsung Wang. The primary goals were to ensure that in-progress American Board of Health Physics (ABHP) testing applicants were supported and their information was accurately transferred, all assets of the AAHP/ABHP were accounted for and moved, and to minimize disruption to our members. CMA is an Association Management Company with triple-accreditation by the Association Management Company Institute (AMCI), the Advertising Specialty Institute (ASI), and the International Airlines Travel Agent Network (IATAN). - Our website and database management company, <u>Prolydian</u>, keeps track of our ABHP application process, membership database, and our

website. Again, this is a case of changing the way we do business that has been around for decades. In 2020, the recertification process went electronic, but there were some stumbles along the way. The system that was intended to make your life easier for recertification actually made it somewhat harder for you, and much harder for the Continuing Education Committee. We had a major shift mid-year, and in the last week of December were able to release the next version of the Continuing Education Credits tracking system. If you have not had a chance to check it out, please do so! CHPs can now continuously update their CECs online and apply for CECs throughout their 4-year recertification period, so I encourage you to record/apply for your CECs as they come.

• "The COVID." Although we're all tired of talking about it, I would be remiss if I didn't mention the FABULOUS job the Board did in arranging for those who wanted to take the exam as scheduled in the summer of 2020 to take it, and for those who wanted to take it next year to be allowed the opportunity to do that. The Exam Site Committee [Jeff Bruner (Chair), Kara Beharry, Dan Menchaca, and William Uhland] were presented with a surprising challenge to find places for those who wanted to take the test that were geographically appropriate, open and available, and safe. WELL DONE, colleagues! Regarding CECs in 2021, making them available to Academy members will be one of my top-level goals.

There will be plenty of time for me to communicate more throughout the year, so I will stop there for now. I look forward to serving you as President this year.

#### CALL FOR AAHP NOMINATIONS

The American Academy of Health Physics (AAHP) Nominating Committee is seeking candidates to run for Academy offices on the 2021 ballot. Successful candidates will take office on January 1, 2022. We need nominees for the offices of President-elect, Secretary, and Director. All three positions are three-year terms.

#### Nominees must be:

- 1. Current plenary members of the Academy (either active or emeritus); and
- 2. Not serving an appointment to either of the Exam Panels, or as a member of the ABHP, at the time that they take office.
